The Department of Higher Education Government of Jammu & Kashmir announces the commencement of admissions for passouts of Secondary School Examination (Class 12th) - Session Annual Private Biannual 2025 for various Four Year Undergraduate Programs (FYUGP) with multiple-exit options across Degree colleges of J&K (for leftover vacant seats only), for the Academic Session 2025-2026.

All aspirants need to register on the centralised admission website <https://jkadmission.samarth.ac.in/> before proceeding for admissions.

### **Admission Timeline**

<b>On-Spot admission to colleges</b> Aspirants need to approach the concerned college after registering their basic details on the Samarth Portal for Admission. <ul style="list-style-type: none"> <li>This round will be open for Passouts of Secondary School Examination (Class 12th) - Session Annual Private Biannual 2025 as well as passouts of Higher Secondary Part II (Class 12th) - Session Annual 2025 who had not taken admission in the earlier rounds <b>for leftover vacant seats only</b>.</li> <li>Aspirants will be required to visit the college campus where they are interested to seek admission to check the availability of seats, on-spot confirmation of admission and payment of fee.</li> <li>In case the number of seats available in a program are limited, admissions shall be given by preparing merit lists on the basis of 10+2 marks that shall be issued every 3 days after consolidating applications received in the intervening period till the vacancies are filled.</li> <li><b>Aspirants who have already secured admission in some college in the earlier rounds shall not be eligible to apply in this round.</b></li> <li>Confirmation of admission shall be subject to the minimum number of students for a course as already specified by the Higher Education Department.</li> </ul>	September 29- October 04, 2025
